WARNINGS AND SAFETY INFORMATION

storage / expiry date	Store face mask in original packaging in a cool and dry place without additional weight, protect from direct sunlight. Do not store near ozone sources (laser printers, copiers). The actual expiry time in use cannot be specified in general terms, as it depends on the general conditions of use. An individual risk assessment must be carried out in each case. The expiry date - valid for proper storage - is stated on the packaging.
use and control	Always use face masks only for their intended use. A check/risk assessment must be carried out to ensure that the face mask is suitable for the intended use. Change the mask when it is soaked through.
disposal	Used face masks must be disposed of in accordance with the disposal regulations of the local waste disposal company. Unused face masks can be disposed of with household waste.
warnings	Change the mask when it is soaked through. Article is highly flammable - keep away from heat and/or fire.
donning and doffing instructions	PUTTING ON: Place the mask over the mouth and nose on the face and secure it in place with straps or ear loops. Adjust the flexible nose clip to the shape of the face so that as little air as possible can escape from the upper end. PULL OUT: Loosen the straps to remove the face mask from the face. Do not touch the fleece material. Disinfect your hands after disposing of the face mask.
